1. The Regular Meeting of the Saline Township Board was called to order by Supervisor Marion on November 14, 2011 at 7:30PM at the Saline Town Hall, 5731 Braun Road, Saline, MI 48176.
2. Members present: Supervisor Marion, Clerk Marion, Treasure Gordon, Trustee R. Marion and Trustee R. Prehn. Three other citizens were present.
3. Mr. Prehn led the Pledge of Allegiance.
4. Mrs. J. Gordon moved, supported by Mr. R. Marion that the agenda be approved be as presented.
5. Mr. R Prehn moved, supported by Mr. R. Marion, that the consent agenda be approved as presented.
  - a. Approve minutes from October 10<sup>th</sup> regular meeting.
  - b. Receive Clerk's budget, Financial Report
  - c. Approve Accounts Payable in the amount of \$9,793.93
  - d. Approve November Payroll in the amount of \$5,186.99
6. Citizens were offered a chance to address the Board regarding items not already on the agenda. No citizen comments.
7. Cindy Czubko addressed the Board with regards to the Historic to Main Street Program. Currently the program is made of mostly volunteers but looking to become a member of the Main Street Select Community through the State of Michigan. Three communities will be chosen; the Township supports the efforts to keep the downtown area a strong and vibrant place to visit. The Township will submit a letter to the program so that it is included with their application to become part of the Main Street Select Community Program.
8. Supervisor Marion commented on the following:
  - a. Board of Review will meet in December for their regular meeting. Mr. Bill Lutz who served on the Board for many years has passed; there was a moment of silence. A replacement for Mr. Lutz will be decided by the Board at the December regular meeting.
  - b. The Board approved to extend the current Resolution that is in place with regards to Medical Marijuana. A motion was made by Mr. Robert Marion and supported by Mr. Robert Prehn. Ayes 5 Nays 0
  - c. Supervisor Marion reported that the Sheriff's Department is now sending updates as to the activity within the township. These results will be brought to regulars meeting as they are received.
9. Clerk Marion reported the November 8, 2011 election results.

10. Insurance to Burnham & Flower was approved subject to the Zoning Coverage being added / increased. A motion was made by Mr. Robert Prehn and supported by Mr. Robert Marion. Ayes 5 Nays 0. Payment will be made prior to the December meeting.
11. No Trustees Report
12. Zoning/Building Administrator –Rita Fatel’s has not made the agreed upon installments to the township for work that was completed at her home; the township is looking into placing a lien on her home/tax bill. A resident in Oak Park called with a complaint on barking dogs, it has been explained to the resident that there is nothing the township can do at this point; it was suggested that an Association be formed by the residents. It was clarified that the township along with equalization will keep track of the property splits within the township; a new Sliding Scale is in place. Still unclear as to who will be responsible for the final road work needed in Oak Park in order for WCRC to maintain the snow removal.
13. No Fireboard Report
14. Township Hall Manager reported that the new furnace is in and working.
15. Board Member Comments – Mr. Judy Gordon will be renewing her notary stamp. The township will be stocking up on stamps; price due to go up in 2012.
16. The meeting adjourned at 8:45 pm.
